ORDER OF AN EXECUTIVE OFFICER

Re: The Drinking Water System, Blueridge Estates Water Co-op, located in Calgary, Alberta and municipally described as Blueridge Rise NW Calgary, Alberta

Re: The Drinking Water Supply located in Calgary, Alberta and municipally described as:

Blueridge Mountain Estates Water Coop
Blueridge Rise NW,
Calgary, Alberta

WHEREAS I, an **Executive Officer** of the **Calgary Health Region**, have inspected the above noted Drinking Water Supply pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted Drinking Water Supply which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. Inadequate treatment of water source, not sufficient to remove "*Giardia* cysts" and "*Cryptosporidium* oocysts."

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act Nuisance and General Sanitation Regulation, Alberta Regulation 243/2003 exist in and about the above noted Drinking Water Supply, namely:

- a. "Inadequate treatment of source water" which is in contravention of the Nuisance and General Sanitation Regulation Section 11, which states "Where a person provides a source of water that the person intends to be used or realizes or ought to realize will be used by the public for human consumption, the person shall ensure that the water is potable".

AND WHEREAS by virtue of the foregoing, the above noted Source of Water is hereby declared **unfit for human consumption**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately issue an Advisory to all users of the Drinking Water Supply for the Blueridge Estates Water System to heat water to a rolling boil for one (1) minute, or distill water, prior to any use for consumptive purposes including teeth brushing, and,
2. That the Owner undertake and diligently pursue the completion of the following work in and about the above noted Drinking Water Supply, namely:
 - a. Prepare a proposal outlining the upgrades and/or alterations to the Water System necessary to ensure a potable water supply along with scheduled completion dates and submit to the Health Region for review before September 28, 2007.
 - b. Complete all necessary upgrades and/or alterations to the Water System to ensure each connection is serviced with a potable water supply before February 15, 2008.
3. That, until such time as the work referred to in paragraph 2 is completed and the Source of Water is shown to be potable to the satisfaction of the undersigned, or an executive officer of the Calgary Health Region, that this order shall remain in effect.

The Owner is advised that the Public Health Act empowers the Calgary Health Region to carry out the terms of this Order on the Owner's behalf and at the Owner's expense should the Owner fail to comply with the terms hereof.
