

**IN THE MATTER OF THE PUBLIC HEALTH ACT – ALBERTA**  
**ORDER OF AN EXECUTIVE OFFICER**

**Re:** The Food Establishment located in Banff National Park, Alberta and municipally described as:

Lake Agnes Teahouse  
Backcountry, Banff National Park

WHEREAS I, an **Executive Officer** of the **Calgary Health Region**, have inspected the above noted Food Establishment pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted food establishment which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. Water source is under the influence of surface water and there is inadequate treatment provided.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act, and the Food Retail and Foodservices Code exist in and about the above noted food establishment, namely:

- a. Water source is under the influence of surface water and there is inadequate treatment provided. This is in contravention of Section 2.10 (d) of the Food Retail and Foodservices Code which states “the use of non-potable water in a food establishment is prohibited.”

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted food establishment, namely:
  - a. Post signage provided by the health region at all water outlets and in a location visible to the public stating that the water is not safe for human consumption.
  - b. Ensure that all food is of low risk and is approved by the Calgary Health Region.
  - c. Ensure that all food processing and preparation in the kitchen is done with potable boiled/bottled water.
  - d. All utensils, counter tops and food contact surfaces shall be cleaned and sanitized with an approved sanitizing step utilizing potable boiled/bottled water.
  - e. Hands shall be disinfected using an alcohol-based hand sanitizer after being properly washed and dried.

2. The work referred to in paragraph 1 a. through d. shall take place immediately. The work referred to in paragraph 1 e. shall be completed prior to the commencement of the summer 2008 season.

The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal.***

***The Owner is advised that the Public Health Act empowers the Calgary Health Region to carry out the terms of this Order on the Owner's behalf and at the Owner's expense should the Owner fail to comply with the terms hereof.***
