

**IN THE MATTER OF THE PUBLIC HEALTH ACT – ALBERTA**  
**ORDER OF AN EXECUTIVE OFFICER**

**Re:** The Food Establishment located in Calgary, Alberta and municipally described as:

**Best Choice Pizza**

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted Food Establishment pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted food establishment which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. Pizza meat was placed in wet and ripped plastic bags inside the cold inserts.
- b. No paper towel available in staff washroom.
- c. Rolls of paper towels in the kitchen were not in proper dispensers.
- d. Staff washroom was dirty. Light switch cover was blackened with a layer of dirt.
- e. Walk-in cooler shelves and door were dirty.
- f. Dry storage room was cluttered and has accumulation of spilled food.
- g. Spilled food accumulated on bottom of the chest freezer.
- h. Storage shelves behind the oven were cluttered with newspaper, and opened take-out food containers.
- i. Floor edges and wall base throughout the facility have build up of dirt.
- j. Poor general sanitation and maintenance since 2004.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act Food Regulation, Alberta Regulation 31/2006, and the Food Retail and Foodservices Code, exist in and about the above noted food establishment, namely:

- a. Pizza meat is placed in wet and ripped plastic bags inside the cold inserts. This is in contravention of Section 23 of the Food Regulation.
- b. No paper towel available in staff washroom. This is in contravention of Section 30(4) of the Food Regulation.
- c. Rolls of paper towels in the kitchen were not in proper dispensers. This is in contravention of Section 30(4) of the Food Regulation.

- d. Staff washroom is dirty. Light switch cover is blackened with a layer of dirt. This is in contravention of Section 28(3) of the Food Regulation.
- e. Walk-in cooler shelves and door are dirty. This is in contravention of Section 28(2) of the Food Regulation.
- f. Dry storage room is cluttered and has accumulation of spilled food. This is in contravention of Section 28(3) of the Food Regulation.
- g. Spilled food accumulated on bottom of the chest freezer. This is in contravention of Section 28(2) of the Food Regulation.
- h. Storage shelves behind the oven are cluttered with newspaper, and opened take-out food containers. This is in contravention of Section 28(3) of the Food Regulation.
- i. Floor edges and wall base throughout the facility have built up of dirt. This is in contravention of Section 28(3) of the Food Regulation.
- j. Poor general sanitation and maintenance since 2004. This is in contravention of Section 28(3) of the Food Regulation.

AND WHEREAS by virtue of the foregoing, the above noted premises are hereby declared to be **CLOSED**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately CLOSE the above noted food establishment
2. That the Owner undertake and diligently pursue the completion of the following work in and about the above noted food establishment, namely:
  - a. Ensure that pizza meat is placed directly in clean and sanitized cold inserts.
  - b. Provide paper towel in a proper dispenser in the staff washroom.
  - c. Provide paper towel in a proper dispenser at the kitchen hand sink.
  - d. Thoroughly clean the staff washroom.
  - e. Thoroughly clean and sanitize entire premises and all food contact surfaces. Ensure that all surfaces are free from grease, food build-up, dirt, dust and all debris.
  - f. Develop and implement an appropriate cleaning and sanitizing schedule. All staff MUST be familiar with the required cleaning and sanitizing procedures and must follow the schedule regularly.
3. That, until such time as the work referred to in paragraph 2 (a) through (f) is completed to the satisfaction of the undersigned, or an executive officer of Alberta Health Services, the above noted premises shall remain closed.
