

IN THE MATTER OF THE PUBLIC HEALTH ACT – ALBERTA
ORDER OF AN EXECUTIVE OFFICER

Re: The mobile Food Establishment vehicle operating in Calgary, Alberta and described as:
The Fry Guy #2
VIN: CPL3283320935
At the time of issuance of the verbal order the above vehicle was located in the parking lot described municipally as 3525 26 Avenue SE, Calgary, Alberta.

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted Food Establishment pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted food establishment which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. Vehicle can not supply running water at the time of inspection.
- b. Premises is dirty.
- c. Food preparation surfaces are dirty.
- d. Coolers for storing perishables are black with grime.
- e. There is no soap for hand washing at the sink.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted food establishment, namely:

- a. There was no supply of water to the hot dog cart. This is in contravention of Section 17(1)(f)(i) of the Food Regulation.
- b. There was no supply of hand soap at the hand washing sink. This is in contravention of Section 17 (1) (e) of the Food Regulation.
- c. Premise was dirty, including food preparation surfaces and perishable food storage containers. This is in contravention of Section 28 (2) of the Food Regulation.

AND WHEREAS by virtue of the foregoing, the above noted premises are hereby declared to be **closed**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately close the above noted food establishment

ORDER OF AN EXECUTIVE OFFICER

Re: The mobile Food Establishment operating in Calgary, Alberta and described as The Fry Guy #2, VIN CPL3283320935; operating at a location at the time of inspection municipally described as 3525 26 Avenue SE, Calgary, Alberta.

2. That the Owner undertake and diligently pursue the completion of the following work in and about the above noted food establishment, namely:
 - a. Ensure there is an adequate supply of hot and cold running water to the hot dog cart at all times during operation.
 - b. Ensure that the food establishment always has an adequate supply of liquid hand washing soap, in a proper dispenser, while in operation.
 - c. Ensure that the vehicle including food preparation and storage areas is maintained in a clean and sanitary condition.
3. That, until such time as the work referred to in paragraph 2 is completed to the satisfaction of the undersigned, or an executive officer of Alberta Health Services, the above noted premises shall remain closed.

The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal.

The Owner is advised that the Public Health Act empowers Alberta Health Services to carry out the terms of this Order on the Owner's behalf and at the Owner's expense should the Owner fail to comply with the terms hereof.
