

IN THE MATTER OF THE PUBLIC HEALTH ACT – ALBERTA
ORDER OF AN EXECUTIVE OFFICER

(the “**Owner**”)

Re: The Food Establishment located in the MD of Foothills, Alberta and municipally described as:

S.R. Packaging
NW 24-20-1-W5
MD of Foothills, Alberta

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted Food Establishment pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted food establishment which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. Water supplying the premises may be unsafe for human consumption as indicated by the presence of Total Coliform and E-coli bacteria in the June 21/2010 water sample.
- b. The well water supply was observed to be groundwater under the direct influence of surface water.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted food establishment, namely:

- a. Water supplying the premises may be unsafe for human consumption as indicated by the presence of Total Coliform and E-coli bacteria in the June 21/2010 water sample which is in contravention of Section 17(1)(f)(i).
- b. The well water supply was observed to be groundwater under the direct influence of surface water which is in contravention of Section 17(1)(f)(i).

AND WHEREAS by virtue of the foregoing, the above noted premises are hereby declared to be **closed**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately close the above noted food establishment
2. (a) That the food establishment remain closed until satisfactory provisions are in place, approved by an Executive Officer of Alberta Health Services, to provide a safe food supply.

(b) Submit two consecutive water samples, taken at least 24 hrs apart, to the provincial laboratory.
3. That, until such time as the work referred to in paragraph 2(a) is completed to the satisfaction of the undersigned, or an executive officer of Alberta Health Services and the samples from 2(b) are confirmed satisfactory, the above noted premises shall remain closed.

Section 5(2) of the Public Health Act provides that a person who is directly affected by this Order and considers himself or herself aggrieved hereby may appeal the same to the Public Health Appeal Board, 24th Floor, Telus Plaza North Tower, 10025 Jasper Avenue, Edmonton AB T5J 2N3, within ten (10) days. The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal.

The Owner is advised that the Public Health Act empowers Alberta Health Services to carry out the terms of this Order on the Owner's behalf and at the Owner's expense should the Owner fail to comply with the terms hereof.
