

IN THE MATTER OF THE PUBLIC HEALTH ACT – ALBERTA
ORDER OF AN EXECUTIVE OFFICER

(the “**Owner**”)

Re: The Food Establishment located in Calgary, Alberta and municipally described as:

Deluxe Dogs #00186
200 Block 8th Ave SW
Calgary, Alberta

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted Food Establishment pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted food establishment which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. There was no supply of hot and cold running water to the cart.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted food establishment, namely:

- a. There was no supply of hot and cold running water to the cart. This is in contravention of Section 17(1)(f)(i) of the Food Regulation.

AND WHEREAS by virtue of the foregoing, the above noted premises are hereby declared to be **CLOSED**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately **CLOSE** the above noted food establishment
2. That the Owner undertake and diligently pursue the completion of the following work in and about the above noted food establishment, namely:
 - a. Restore an adequate supply of hot and cold running water to the cart. There must be a supply of hot and cold running water available at all times while the cart is in operation.

ORDER OF AN EXECUTIVE OFFICER

Re: The Food Establishment, Deluxe Dogs #00186, located in Calgary, Alberta and municipally described as 200 Block, 8th Ave. S.W. Calgary, Alberta

3. That, until such time as the work referred to in paragraph 2 (a) is completed to the satisfaction of the undersigned, or an executive officer of Alberta Health Services, the above noted premises shall remain closed.

Dated at Calgary, Alberta, this 1st day of November, 2010, in confirmation of a verbal order issued on the 31th day of October, 2010.

The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal.

The Owner is advised that the Public Health Act empowers Alberta Health Services to carry out the terms of this Order on the Owner's behalf and at the Owner's expense should the Owner fail to comply with the terms hereof.
