

**IN THE MATTER OF THE PUBLIC HEALTH ACT – ALBERTA**  
**ORDER OF AN EXECUTIVE OFFICER**

**Re:** The Food Establishment located in Cochrane, Alberta and municipally described as:

Extra Food Store #9013 – Water Dispensing Machine  
Cochrane, Alberta

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted Food Establishment pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted food establishment which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. A water sample submitted April 15, 2010 showed the presence of a HPC of 120 CFU per ml.
- b. A water sample submitted April 19, 2010 showed the presence of an HPC of 180 CFU per ml.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted food establishment, namely:

- a. The water sample submitted April 15, 2010 showed the presence of a HPC of 120 CFU per ml is in contravention of Section 24 of the Food Regulation and Appendix 1 of the Alberta Food Retail and Foodservices Code.
- b. The water sample submitted April 19, 2010 showed the presence of a HPC of 180 CFU per ml is in contravention of Section 24 of the Food Regulation and Appendix 1 of the Alberta Food Retail and Foodservices Code.

AND WHEREAS by virtue of the foregoing, the above noted premises are hereby declared to be **closed**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately close the water dispensing machine located at above noted food establishment
2. That the Owner undertake and diligently pursue the completion of the following work in and about the above noted food establishment, namely:
  - a. Thoroughly clean and sanitize all parts of the water bottling system.
  - b. Submit a water sample from the in-store water machine to the Provincial Laboratory for Public Health.
3. That until such time as the work referred to in paragraph 2(a) is completed to the satisfaction of and Executive Officer of Alberta Health Services and bacteriological samples submitted under paragraph 2(b) are satisfactory, the above noted water dispensing machine shall remain closed.
