

IN THE MATTER OF THE PUBLIC HEALTH ACT – ALBERTA
ORDER OF AN EXECUTIVE OFFICER

(the “**Owner**”)

Re: The Food Establishment located in Calgary, Alberta and municipally described as:

Indian Aroma
13-7750 Ranchview Drive N.W
Calgary, Alberta

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted Food Establishment pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted food establishment which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. There were mouse droppings throughout the front grocery area on shelves and on the floor under and between shelves, pallets and equipment.
- b. There was an accumulation of dirt, grime and debris on the floor in hard to reach areas.
- c. There is an accumulation of food spills or debris in the base of coolers, freezers and food storage containers.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted food establishment, namely:

- a. There were mouse droppings throughout the front grocery area on shelves and on the floor under and between shelves, pallets and equipment. This contravenes the AR 31/2006 Section 21(1).
- b. There was an accumulation of dirt, grime and debris on the floor in hard to reach areas. This contravenes the AR 31/2006 Section 28(2).
- c. There is an accumulation of food spills or debris in the base of coolers, freezers and food storage containers. This contravenes the AR 31/2006 Section 28(2).

AND WHEREAS by virtue of the foregoing, the above noted premises are hereby declared to be **closed**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately close the above noted food establishment
2. That the Owner undertake and diligently pursue the completion of the following work in and about the above noted food establishment, namely:
 - a. Clean and disinfect all shelving, floors and equipment in the facility.
 - b. Check all food packaging and discard any items that show evidence of rodent damage or contamination.
 - c. Organize all food and non-food items on shelves and equipment. Store all items elevated off the floor.
 - d. Store all open food packages in rodent proof containers.
 - e. Take all steps necessary to eliminate the rodent infestation and vermin proof the facility.
 - f. Provide a written cleaning procedure. The procedure must include the cleaning and sanitizing requirements for the food establishment and for all equipment and utensils in that are not washed in a dishwasher and a list of all cleaning and sanitizing agents used in the commercial food establishment, including their concentrations and uses.
3. That, until such time as the work referred to in paragraph 2 is completed to the satisfaction of the undersigned, or an executive officer of Alberta Health Services, the above noted premises shall remain closed.

Section 5(2) of the Public Health Act provides that a person who is directly affected by this Order and considers himself or herself aggrieved hereby may appeal the same to the Public Health Appeal Board, 24th Floor, Telus Plaza North Tower, 10025 Jasper Avenue, Edmonton AB T5J 2N3, within ten (10) days. The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal.

The Owner is advised that the Public Health Act empowers Alberta Health Services to carry out the terms of this Order on the Owner's behalf and at the Owner's expense should the Owner fail to comply with the terms hereof.
