

IN THE MATTER OF THE PUBLIC HEALTH ACT – ALBERTA
ORDER OF AN EXECUTIVE OFFICER

Re: The Food Establishment located in Longview, Alberta and municipally described
as:

Longview Jerky Shop

Longview, Alberta

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the
above noted Food Establishment pursuant to the provisions of the **Public Health Act**,
RSA 2000, c. P-37, as amended;

AND WHEREAS such an inspection disclosed that the following conditions exist in and
about the above noted food establishment which are or may become injurious or
dangerous to the public health or which might hinder the prevention or suppression of
disease, namely:

- a. Food preparation was being done without a water supply to the facility.

AND WHEREAS such an inspection disclosed that the following breaches of the Public
Health Act Food Regulation, Alberta Regulation 31/2006 and the Food Retail and
Foodservices Code exist in and about the above noted food establishment, namely:

- a. Food preparation was being done without a water supply to the facility. This
contravenes the AR 31/2006 Section 17(1)(f)(i) of the Regulation.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately cease any food preparation, production and any open
food handling.
2. That, until such time that water service has been restored and instruction is
received from the undersigned, or an executive officer of Alberta Health Services,

all food preparation, production and any open food handling shall cease. Retail sales of pre-packaged foods can continue.

Dated at Okotoks, Alberta, this 1st day of November, 2010, confirming the verbal order given on October 27, 2010.

Section 5(2) of the Public Health Act provides that a person who is directly affected by this Order and considers himself or herself aggrieved hereby may appeal the same to the Public Health Appeal Board, 24th Floor, Telus Plaza North Tower, 10025 Jasper Avenue, Edmonton AB T5J 2N3, within ten (10) days. The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal.

The Owner is advised that the Public Health Act empowers Alberta Health Services to carry out the terms of this Order on the Owner's behalf and at the Owner's expense should the Owner fail to comply with the terms hereof.
