

IN THE MATTER OF THE PUBLIC HEALTH ACT – ALBERTA
ORDER OF AN EXECUTIVE OFFICER

Re: The Food Establishment Real Canadian Superstore # 1540 located in Airdrie, Alberta and municipally described as:

300 Veterans Bv NE
Airdrie, Alberta

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted Food Establishment pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted food establishment which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. Water samples drawn from the Dyna Pro water dispenser located in the store on April 13, May 5 and May 12, 2010 and tested for bacteriological quality by the Provincial Laboratory for Public Health (Microbiology) were unsatisfactory with heterotrophic plate counts of 310/mL, 1090/mL and 520/mL respectively.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted food establishment, namely:

- a. Water samples drawn from the Dyna Pro water dispenser located in the store on April 13, May 5 and May 12, 2010 and tested for bacteriological quality by the Provincial Laboratory for Public Health (Microbiology) were unsatisfactory with heterotrophic plate counts of 310/mL, 1090/mL and 520/mL respectively, contravening sections 2(6) and 17(1)(f)(i) of AR 31/2006 and Appendix F of the Code.

AND WHEREAS by virtue of the foregoing, the above noted **Dyna Pro water dispensing system** on the premises are hereby declared to be **closed**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately close the above noted water dispensing system

ORDER OF AN EXECUTIVE OFFICER

Re: The water dispenser at Real Canadian Superstore located in Airdrie, Alberta and municipally described as 300 Veterans Bv NE, Airdrie, Alberta

2. That the Owner undertake and diligently pursue the completion of the following work in and about the above noted food establishment, namely:
 - a. Disinfect the water dispensing system and submit at least two water samples to the Provincial Laboratory of Public Health over a period of greater than 24 hours.
3. That, until such time as the work referred to in paragraph 2 is completed to the satisfaction of the undersigned, or an executive officer of Alberta Health Services, and the results of the tests done by the Laboratory are satisfactory, the above noted premises shall remain closed.

Section 5(2) of the Public Health Act provides that a person who is directly affected by this Order and considers himself or herself aggrieved hereby may appeal the same to the Public Health Appeal Board, 24th Floor, Telus Plaza North Tower, 10025 Jasper Avenue, Edmonton AB T5J 2N3, within ten (10) days. The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal.

The Owner is advised that the Public Health Act empowers Alberta Health Services to carry out the terms of this Order on the Owner's behalf and at the Owner's expense should the Owner fail to comply with the terms hereof.
