**ORDER OF AN EXECUTIVE OFFICER**

**Re:** The water bottling machine located in Airdrie, Alberta and municipally described as:

Real Canadian Superstore #1540 – Water Machine  
Airdrie, Alberta

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted water bottling machine located in Real Canadian Superstore #1540 pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted water bottling machine which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. Water samples submitted from the water bottling machine on July 27, August 4 and 11 revealed the presence of 140 cfu/mL, 140 cfu/mL and 240 cfu/mL total aerobic bacteria respectively.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted food establishment, namely:

- a. Water samples submitted from the water bottling machine on July 27, August 4 and 11 revealed a presence of 140 cfu/mL, 140 cfu/mL and 240 cfu/mL total aerobic bacteria respectively. This is in contravention to Appendix F of the Code.

AND WHEREAS by virtue of the foregoing, the above noted water bottling machine is hereby declared to be **closed**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately **close** the above noted water bottling machine.
2. That the Owner undertake and diligently pursue the completion of the following work in and

about the above noted water bottling machine, namely:

- a. Thoroughly clean and sanitize all parts of the water bottling system.
  - b. Submit water samples from the water bottling machine to the Provincial Laboratory for Public Health (Microbiology).
3. That, until such time as the work referred to in paragraph 2(a) is completed to the satisfaction of the undersigned, or an executive officer of Alberta Health Services, and the bacteriological water samples submitted under paragraph 2(b) are satisfactory, the above noted premises shall remain closed.

Dated at Calgary, Alberta, this 17<sup>th</sup> day of August, 2010, confirming a verbal order issued on the 16<sup>th</sup> day of August, 2010.
