ORDER OF AN EXECUTIVE OFFICER

Re: The Food Establishment located in Calgary, Alberta and municipally described as:

Sausage Party #00013
800 Block MacLeod Trail SE
Calgary, Alberta

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted Food Establishment pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted food establishment which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. There was no supply of hot or cold running water available at the handwash sink on the mobile food cart;
- b. A water sample has not been submitted since January 8, 2010;
- c. The owner was unable to provide evidence that he has taken and completed a Provincial Certification FoodSafe Course.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted food establishment, namely:

- a. There was no supply of hot or cold running water available at the handwash sink on the mobile food cart, contravening Section 17(1)(f)(i) of the Food Regulation AR 31/2006;
- b. A water sample has not been submitted since January 8, 2010 contravening Section 2.10(c) of the Alberta Food Retail and Foodservices Code;
- c. The owner was unable to provide evidence that he has taken and completed a Provincial Certification FoodSafe Course contravening Section 31(1) of the Food Regulation AR 31/2006.

AND WHEREAS by virtue of the foregoing, the above noted premises are hereby declared to be **closed**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

ORDER OF AN EXECUTIVE OFFICER

Re: The Food Establishment located in Calgary, Alberta and municipally described as 800 Block MacLeod Trail SE, Calgary, Alberta

1. That the Owner immediately **close** the above noted food establishment
2. That the Owner undertake and diligently pursue the completion of the following work in and about the above noted food establishment, namely:
 - a. Ensure the mobile food cart has an adequate supply of hot and cold running water at all time during operation periods;
 - b. A water sample from water in the holding tank of this mobile hot dog cart must be submitted to the Provincial Laboratory of Public Health and have satisfactory results;
 - c. The owner must register for the next available FoodSafe Course and complete by April 9, 2010
 - d. The owner must successfully complete "Food Safety in Food Service: A Home Study Course."
3. That, until such time as the work referred to in paragraph 2 is completed to the satisfaction of the undersigned, or an executive officer of Alberta Health Services, the above noted premises shall remain closed.

Section 5(2) of the Public Health Act provides that a person who is directly affected by this Order and considers himself or herself aggrieved hereby may appeal the same to the Public Health Appeal Board, 24th Floor, Telus Plaza North Tower, 10025 Jasper Avenue, Edmonton AB T5J 2N3, within ten (10) days. The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal.

The Owner is advised that the Public Health Act empowers Alberta Health Services to carry out the terms of this Order on the Owner's behalf and at the Owner's expense should the Owner fail to comply with the terms hereof.
