

**IN THE MATTER OF THE PUBLIC HEALTH ACT – ALBERTA**  
**ORDER OF AN EXECUTIVE OFFICER**

**Re:** The Food Establishment located in Calgary, Alberta and municipally described as:  
A Plus 1 Convenience Store  
#1, 11625 Elbow Drive SW  
Calgary, Alberta T2W 1G8

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted Food Establishment pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted food establishment which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. The water vending unit was installed without health approval,
- b. The water vending unit is located outside and is not protected from contamination,
- c. Water samples from the water vending unit have not been submitted for bacteriological analysis.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted food establishment, namely:

- a. The water vending unit was installed without health approval. This contravenes Section 16 of the Food Regulation.
- b. The water vending unit is located outside and is not protected from contamination. This contravenes Section 23 (1) of the Food Regulation.
- c. Water samples from the water vending unit have not been submitted for bacteriological analysis. This contravenes Section 17 (f)(i) of the Food Regulation.

AND WHEREAS by virtue of the foregoing, the “Waterstation TM” water vending unit at the above noted premises are hereby declared to be **CLOSED**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately CLOSE the “Waterstation TM” water vending unit.

ORDER OF AN EXECUTIVE OFFICER

Re: The Food Establishment located in Calgary, Alberta and municipally described as A Plus 1 Convenience Store, SW Calgary, Alberta

2. That the Owner undertake and diligently pursue the completion of the following work in and about the above noted food establishment, namely:
  - a. Provide an acceptable and adequate means of protection from contamination for the water vending unit.
  - b. Submit a water sample from the water vending unit to the Provincial Laboratory for Public Health and continue to submit water samples on a weekly basis hereafter.
  - c. Obtain required Health Approval.
3. That, until such time as the work referred to in paragraph 2 is completed to the satisfaction of the undersigned, or an executive officer of Alberta Health Services, the above noted "Waterstation TM" water vending unit shall remain closed.
4. In the event that the "Waterstation TM" water vending unit is completely removed from the facility and property, this closure order shall be rescinded.

The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal.***

***The Owner is advised that the Public Health Act empowers Alberta Health Services to carry out the terms of this Order on the Owner's behalf and at the Owner's expense should the Owner fail to comply with the terms hereof.***
