

ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE

RE: The food establishment located in Calgary, Alberta and municipally described as:
Calgary Food Services, Bay 7 4215 61 Ave SE

WHEREAS I, an **Executive Officer of Alberta Health Services**, have inspected the above premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. Three egg sandwich food samples are positive for *Salmonella spp.*
- b. There is a lack of hand washing among the food handling staff.
- c. Staff demonstrate an improper method of hand washing

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted food establishment, namely:

- a. Three egg sandwich food samples are positive for *Salmonella spp.* This contravenes the AR 31/2006 Section 23(1)(a).
- b. There is a lack of hand washing among the food handling staff. This contravenes the AR 31/2006 Section 30(1)(d)
- c. Staff demonstrate an improper method of hand washing. This Contravenes the AR 31/2006 Section 30(1)(d).

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately close the above noted food establishment.
2. That the owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Discard all potentially *Salmonella spp* infected products.
 - b. Ensure all staff members attend an approved food safe course to learn the proper method and importance of hand washing.
3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted food establishment shall remain closed.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.

YOU HAVE THE RIGHT TO APPEAL

may appeal the decision within ten (10) days after receiving the order to the Public Health Appeal Board located at 24th Floor, Telus Plaza, 10025 - Jasper Avenue, Edmonton, Alberta, T5J 1S6 Telephone (780) 427-2813.

The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal. If you appeal, you may also make an application to the Board for a stay of this Order pending the appeal.
