

## **ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE**

**RE:** The food establishment located in Calgary, Alberta and municipally described as:  
**Canadian Original Pizza, 4117 4<sup>th</sup> Street NW**

**WHEREAS** I, an **Executive Officer of Alberta Health Services**, have inspected the above premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

**AND WHEREAS** such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. There was no hot running water available for use;
- b. There was improper washing of utensils and equipment;
- c. There were improper hand washing stations;
- d. There was a large number of flies throughout the food establishment;
- e. The wire mesh on the upper half of the screen door was missing;
- f. Pizza boxes were stored directly on the floor.

**AND WHEREAS** such inspection disclosed that the following breaches of the Public Health Act Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code 2003 exist in and about the above noted food establishment, namely:

- a. There was no hot running water available for use which is a breach of the Food Regulation AR 31/2006 section 17(1) (f) (i);
- b. There was improper washing of utensils and equipment which is a breach of the Alberta Food Retail & Foodservices Code 2003 section 4.2.8 (b) (ii) & (iii);
- c. There were improper hand washing stations which is a breach of the Alberta Food Retail & Foodservices Code 2.14 (b) (v);
- d. There was a large number of flies throughout the food establishment which is a breach of the Food Regulation AR 31/2006 section 21 (1);
- e. The wire mesh on the upper half of the screen door was missing which is a breach of the Food Regulation AR 31/2006 section 17 (2);
- f. Pizza boxes were stored directly on the floor which is a breach of the Alberta Food Retail & Foodservices Code 2003 section 3.6.5.

**AND WHEREAS**, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately close the above noted food establishment.
2. That the owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
  - a. Repair the hot water tap so that the hot water supply can be turned on;
  - b. Repair the screen door;
  - c. Prevent the entry of flies and other pests at all times;
  - d. Ensure that utensils and equipment are washed in a detergent solution of no less than 45 deg C temperature, rinsed in clean potable water of no less than 45 deg C temperature and sanitized;
  - e. Ensure that hands are washed in warm running water;
  - f. Store all foods, utensils and food containers off the floor and away from walls.

Until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted food establishment shall remain closed.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
