

IN THE MATTER OF THE PUBLIC HEALTH ACT – ALBERTA
ORDER OF AN EXECUTIVE OFFICER

(the “**Owner**”)

Re: The Food Establishment located in Calgary, Alberta and municipally described as:

Deluxe Dogs – CGY-011
200, 7th Avenue SW
Calgary, Alberta

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted Food Establishment pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted food establishment which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. The wastewater system consisting of the drain, lines, and/or tank was leaking the contents onto the sidewalk;
- b. There was insufficient volume of hot and cold water at the handwash sink on the mobile food premises.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act Food Regulation, Alberta Regulation 31/2006, and the Food Retail and Foodservices Code exist in and about the above noted food establishment, namely:

- a. The wastewater system consisting of the drain, lines, and/or tank was leaking the contents onto the sidewalk, which is in contravention of Section 17 (1) (f) (ii) of the Food Regulation;
- b. There was insufficient volume of hot and cold water at the handwash sink on the mobile food premises, which is in contravention of Section 17(1)(f)(i) of the Food Regulation.

AND WHEREAS by virtue of the foregoing, the above noted premises are hereby declared to be **CLOSED**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately **CLOSE** the above noted food establishment
2. That the Owner undertake and diligently pursue the completion of the following work in and

about the above noted food establishment, namely:

- a. Repair and/or replace any or all of the plumbing system consisting of the drain, wastewater lines, tank, etc so no waste water flowing onto the ground and/or sidewalk;
 - b. Ensure there is a supply of hot and cold running water at all times during the operation of the mobile food premises;
 - c. Provide a written assessment of why this mobile food premises runs out of hot and cold running water. Include in the written assessment an appropriate resolution to the issues identified including an evaluation of water and wastewater tank size;
 - d. Complete any work identified in the written assessment.
3. That, until such time as the work referred to in paragraph 2 is completed to the satisfaction of the undersigned, or an executive officer of Alberta Health Services, the above noted premises shall remain closed.

The Owner is advised that the Public Health Act empowers Alberta Health Services to carry out the terms of this Order on the Owner's behalf and at the Owner's expense should the Owner fail to comply with the terms hereof.
