

## **ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE**

**RE:** The food establishment located in Gleichen, Alberta and municipally described as:

**Gleichen Hotel**  
505 Main Street  
Gleichen, Alberta

**WHEREAS** I, an **Executive Officer of Alberta Health Services**, have inspected the above premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

**AND WHEREAS** such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. Evidence of a mouse infestation. Large accumulation of mice droppings located throughout the kitchen and bar area.
- b. Chlorine residual tested at 0ppm on bar glass washer.
- c. Bicycle located in the kitchen area.
- d. Grease buildup on floor under kitchen grill and deep fryers.
- e. No soap located in the ladies washroom.
- f. No soap or paper towel located men's washroom.
- g. Gaps along the base of the bar entrance doors.
- h. No pest control and monitoring program in place.

**AND WHEREAS** such inspection disclosed that the following breaches of the Public Health Act Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted food establishment, namely:

- a. Evidence of a mouse infestation. Large amount of mice droppings located throughout the kitchen and bar area. This contravenes Section 21(1) of the Food Regulation.
- b. Chlorine residual tested at 0ppm on bar glass washer. This contravenes Section 28(3)(a) of the Food Regulation.
- c. Bicycle located in the kitchen area. This contravenes Section 20(1) of the Food Regulation.
- d. Grease buildup on floor under kitchen grill and deep fryers. This contravenes Section 28(2) of the Food Regulation.
- e. No soap located in the ladies washroom. This contravenes Section 2.15(a) of the Food Retail and Foodservices Code.

- f. No soap or paper towel located men's washroom. This contravenes Section 2.15(a) of the Food Retail and Foodservices Code.
- g. Gaps along the base of the bar entrance doors. This contravenes Section 17(2) of the Food Regulation.
- h. No written pest control and monitoring program in place. This contravenes Section 21(2) of the Food Regulation.

**AND WHEREAS**, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the Owner immediately **close** the above noted food establishment.
- 2. That the owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
  - a. Thoroughly clean all the floors and equipment.
  - b. Thoroughly clean and sanitize all food prep counters, utensils and equipment.
  - c. Repair the bar glass washer.
  - d. Remove the bicycle and any articles or materials not associated with the operation of the food establishment.
  - e. Remove all rodent contaminated food products.
  - f. Thoroughly clean the floor under the grill and deep fryers.
  - g. Provide soap, in an appropriate dispenser, in the ladies washroom.
  - h. Provide soap and paper towels, in an appropriate dispenser, in the men's washroom.
  - i. Seal all gaps along the facility entrance doors.
  - j. Provide a written pest control and monitoring program.
- 3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted food establishment shall remain closed.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.

The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal. If you appeal, you may also make an application to the Board for a stay of this Order pending the appeal.
