

IN THE MATTER OF THE PUBLIC HEALTH ACT – ALBERTA
ORDER OF AN EXECUTIVE OFFICER

Re: The Food Establishment located in Calgary, Alberta and municipally described as:

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted Food Establishment pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted food establishment which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. Two display coolers were not functioning properly, the ambient air temperature of the medium sized cooler measured at 20.5 degrees Celsius. Foods probed inside the cooler were above 20 degrees Celsius. The small display cooler had an ambient air temperature of 7 degrees Celsius.
- b. The equipment used in the preparation of food is not cleaned as required. The meat grinder and band saw are contaminated with raw meat debris which appears to have been dried on. Multiple dirty knives with meat debris stored on grease trap contaminated with meat debris and blood. Chest freezer has a build up of ice with blood spills and meat debris.
- c. The preparation area, display coolers, counters and walls were extremely dirty with accumulation of blood, spills, and debris;
- d. Hand wash station did not have paper towel

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted food establishment, namely:

- a. Two display coolers were not functioning properly, the ambient air temperature was measured at 20.5 d and 7 degrees Celsius. Foods probed inside the cooler were above 20 degrees Celsius. This contravenes Section 25(1) (a) and Section

28(3) (a) and (b) of the Food Regulation AR 31/2006.

- b. The equipment used in the preparation of food is not cleaned as required. The meat grinder, band saw are contaminated with raw meat debris which appears to have been dried on. Multiple dirty knives with meat debris stored on grease trap contaminated with meat debris and blood. Chest freezer has a build up of ice with blood spills and meat debris This is in contravention to Section 28(2) of the Food Regulation AR 31/2006.
- c. The preparation area, display coolers, counters and walls were extremely dirty with accumulation of blood, spills, and debris; contravening Section 28 (2) of the Food Regulation AR 31/2006.
- d. The hand wash station did not have paper towel; contravening Section 30 (4) of the Food Regulation AR 31/2006.

AND WHEREAS by virtue of the foregoing, the above noted premises are hereby declared to be **closed**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately close the above noted food establishment
2. That the Owner undertake and diligently pursue the completion of the following work in and about the above noted food establishment, namely:
 - a. Discard all perishable products from the medium sized cooler.
 - b. Ensure the display coolers are repaired and operating properly at temperatures of 4 degrees Celsius or lower.
 - c. Thoroughly clean and sanitize all contaminated equipment and food utensils. Cleaning must be conducted as frequently as required and all items must be in a sanitary condition prior to each night's closure. Cleaned and sanitized utensils must be stored in a clean and sanitary manner. Chest freezer must be defrosted and sanitized.
 - d. All surfaces including, but not limited to floors, walls, shelves, counters, display coolers within the preparation areas, and storage areas must be cleaned;
 - e. Paper towel must be present at the hand wash station
3. That, until such time as the work referred to in paragraph 2 is completed to the satisfaction of the undersigned, or an executive officer of Alberta Health Services, the above noted premises shall remain closed.

The Owner is advised that the Public Health Act empowers Alberta Health Services to carry out the terms of this Order on the Owner's behalf and at the Owner's expense should the Owner fail to comply with the terms hereof.
