

IN THE MATTER OF THE PUBLIC HEALTH ACT – ALBERTA
ORDER OF AN EXECUTIVE OFFICER

Re: The Food Establishment located in Calgary, Alberta and municipally described as:
MacLeod Trail Sushi & BBQ
Unit 100 – 5211 MacLeod Trail SW
Calgary, Alberta

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted Food Establishment pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted food establishment which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. Operating without a valid and subsisting food handling permit from Alberta Health Services.
- b. Kitchen preparation area was under construction and surfaces had not been cleaned or sanitized prior to the introduction of open foods. Surfaces were dirty and cluttered with unnecessary construction supplies.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted food establishment, namely:

- a. Operating without a valid and subsisting food handling permit from Alberta Health Services, which is in contravention of section 3(1)(a)(b) which states that no person shall operate a food establishment unless the person is an operator who holds a valid and subsisting permit for the operation of the food establishment, and the food establishment is identified on the permit as approved by the regional health authority that issued the permit.
- b. The kitchen preparation area was under construction and surfaces had not been cleaned or sanitized prior to the introduction of open foods. Surfaces were dirty and cluttered with unnecessary construction supplies contravening Section 28 (2) of the Food Regulation AR 31/2006;

AND WHEREAS by virtue of the foregoing, the above noted premises are hereby declared to be **closed**;

ORDER OF AN EXECUTIVE OFFICER

Re: The Food Establishment located in Calgary, Alberta and municipally described as MacLeod Trail Sushi & BBQ Unit 100 – 5211 MacLeod Trail SW Calgary, Alberta

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately close the above noted food establishment
2. That the Owner undertake and diligently pursue the completion of the following work in and about the above noted food establishment, namely:
 - a. Obtain a valid food handling permit from Alberta Health Services.
 - b. Discontinue the operation until the kitchen is fully renovated and all surfaces have been cleaned and sanitized to the satisfaction of an Alberta Health Services representative.
3. That, until such time as the work referred to in paragraph 2 is completed to the satisfaction of the undersigned, or an executive officer of Alberta Health Services, the above noted premises shall remain closed.

The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal.

The Owner is advised that the Public Health Act empowers Alberta Health Services to carry out the terms of this Order on the Owner's behalf and at the Owner's expense should the Owner fail to comply with the terms hereof.
