

IN THE MATTER OF THE PUBLIC HEALTH ACT – ALBERTA
ORDER OF AN EXECUTIVE OFFICER

To: Ravinder Mall, Prem Mall & Mall Enterprises Ltd.

(the “**Owner**”)

Re: The Temporary Food Establishment known as **Rajdoot** located at the Calgary Stampede in Calgary, Alberta

WHEREAS we, **Executive Officers of Alberta Health Services**, have inspected the above noted Temporary Food Establishment pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspections disclosed that the following conditions exist in and about the above noted food establishment which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

On July 10, 2011

- a. No hot water available,

On July 11, 2011

- a. No hot water available,
- b. Sinks plugged and not draining,
- c. Premises dirty, messy and unorganized

AND WHEREAS such inspections disclosed that the following breaches of the Public Health Act Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted food establishment, namely:

- a. No hot water available contravening Section 17 (1) (f) (i) of the Food Regulation,
- b. Sinks plugged and not draining contravening Section 17 (1) (f) (ii) and Section 28 (3) of the Food Regulation,
- c. Premises dirty, messy and unorganized contravening Section 28 (2) of the Food Regulation.

AND WHEREAS by virtue of the foregoing, the above noted premises are hereby declared to be **closed**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately close the above noted food establishment

2. That the Owner undertake and diligently pursue the completion of the following work in and about the above noted food establishment, namely:
 - a. Ensure that hot water is available at both hand wash and dishwashing sinks.
 - b. Ensure the waste water drainage system is properly operating and free from defects.
 - c. Ensure the premises are cleaned, organized and well maintained.

3. That, until such time as the work referred to in paragraph 2 is completed to the satisfaction of the undersigned, or an Executive Officer of Alberta Health Services, the above noted premises shall remain closed.

The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal.

The Owner is advised that the Public Health Act empowers Alberta Health Services to carry out the terms of this Order on the Owner's behalf and at the Owner's expense should the Owner fail to comply with the terms hereof.
