

IN THE MATTER OF THE PUBLIC HEALTH ACT – ALBERTA
ORDER OF AN EXECUTIVE OFFICER

Re: Those Premises located in Exshaw, Alberta and municipally described as:

17 Loder Mountain Drive, Exshaw, Alberta

WHEREAS I, an **Executive Officer** of the **Calgary Health Region**, have inspected the above noted premises pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. Unacceptable microbiological quality, as indicated by unsatisfactory water results, taken on:
 - a. July 31, 2007 from the residence – total coliforms numbered 3
 - b. August 20, 2007 from the residence – total coliforms numbered 1
 - c. October 22, 2007 at the well – total coliforms numbered more than 201
 - d. October 22, 2007 from the residence – total coliforms numbered 1

AND WHEREAS such inspection disclosed that the following breaches of the *Public Health Act* (RSA 2000, Chapter P-37) and *Housing Regulation* (Alberta Regulation 173/99) exist in and about the above noted establishment, namely:

- a. Unsatisfactory water sample results indicating an unsafe water source, which contravenes Alberta's *Housing Regulation*, Section 3 (1)(b)(iii), which states "An owner shall ensure that the occupants of the housing premises are supplied with adequate...running hot and cold water that is safe for human consumption."

AND WHEREAS by virtue of the foregoing, the above noted premises are hereby declared to be **under a Boil Water Order**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately undertake and diligently pursue the completion of the following steps and work in and about the above noted premises, namely:
 - a. Provide all tenants at the above noted address with potable water.

- b. Establish a connection to an approved water distribution system, install an approved cistern, or provide a water treatment system that is satisfactory to the Calgary Health Region.
2. The work referred to in paragraph **1(a)** must be completed immediately.
3. Until such time as the work referred to in paragraph **1(b)** is completed to the satisfaction of an Executive Officer of the Calgary Health Region, the above noted premises shall remain under a **Boil Water Order**.

Section 5(2) of the Public Health Act provides that a person who is directly affected by this Order and considers himself or herself aggrieved hereby may appeal the same to the Public Health Appeal Board, 24th Floor, Telus Plaza North Tower, 10025 Jasper Avenue, Edmonton AB T5J 2N3, within ten (10) days. The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal.

The Owner is advised that the Public Health Act empowers the Calgary Health Region to carry out the terms of this Order on the Owner's behalf and at the Owner's expense should the Owner fail to comply with the terms hereof.
