WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted premises pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

ORDER OF AN EXECUTIVE OFFICER

Re: Those premises located in Calgary, Alberta and municipally described as #219 2373 Banff Trail NW, Calgary, Alberta

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. The frame around the air conditioning unit is bare wood.
- b. The bathtub faucet is dripping.
- c. The baseboard is peeling away from the radiator unit.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and Minimum Housing and Health Standards exist in and about the above noted premises, namely:

- a. The frame around the air conditioning unit is bare wood. This is in contravention of the Minimum Housing and Health Standards, Section 5.
- b. The bathtub faucet is dripping. This is in contravention of the Minimum Housing and Health Standards, Section 6(c).
- c. The baseboard is peeling away from the radiator unit. This is in contravention of the Minimum Housing and Health Standards, Section 5(a).

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **closed for tenant accommodation purposes**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That tenants inhabiting the above noted premises be **vacated** no later than 12:00pm, on Wednesday, the 30th day of June, 2010.
2. That, if the above noted premises are to be reoccupied by the public, the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Seal the bare wood around the air conditioning unit so that the wood is non-absorbent.
 - b. Repair the leak from the bathtub faucet.
 - c. Repair the baseboards in the bathroom so that they are in good repair.
3. That, until such time as the work referred to in paragraph 2 is completed to the satisfaction of the undersigned, or an executive officer of Alberta Health Services, the above noted premises shall remain **closed for tenant accommodation purposes**.

The Owner is advised that the Public Health Act empowers Alberta Health Services to carry out the terms of this Order on the Owner's behalf and at the Owner's expense should the Owner fail to comply with the terms hereof.
