WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted premises pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

ORDER OF AN EXECUTIVE OFFICER

Re: Those premises located in Calgary, Alberta and municipally described as **#219 2373 Banff Trail NW, Calgary, Alberta**

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. The stove and oven do not work.
- b. The frame around the air conditioning unit is bare wood.
- c. There is no screen on the front window.
- d. The bathtub faucet is dripping.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and Minimum Housing and Health Standards exist in and about the above noted premises, namely:

- a. The stove and oven do not work. This is in contravention of the Nuisance and General Sanitation Regulation, Section 2(1).
- b. The frame around the air conditioning unit is bare wood. This is in contravention of the Minimum Housing and Health Standards, Section 5.
- c. There is no screen on the front window. This is in contravention of the Minimum Housing and Health Standards, Section 2(b)(iii).
- d. The bathtub faucet is dripping. This is in contravention of the Minimum Housing and Health Standards, Section 6(c).

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **closed for tenant accommodation purposes**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That tenants inhabiting the above noted premises be **vacated** no later than 12:00pm, on Wednesday, the 30th day of June, 2010.
2. That, if the above noted premises are to be reoccupied by the public, the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Ensure the stove and oven are fully operational or remove them from the room altogether.
 - b. Seal the bare wood around the air conditioning unit so that the wood is non-absorbent.
 - c. Ensure the front window is fitted with a screen.
 - d. Repair the leak from the bathtub faucet.
3. That, until such time as the work referred to in paragraph 2 is completed to the satisfaction of the undersigned, or an executive officer of Alberta Health Services, the above noted premises shall remain **closed for tenant accommodation purposes**.
