

**ORDER OF AN EXECUTIVE OFFICER  
UNFIT FOR HUMAN HABITATION  
ORDER TO VACATE**

**To: Beverley Winston McCallum  
(the “owner”)**

**And To: All Occupant(s) of the following Housing premises:**

**5420 Bannerman Drive NW, Calgary, AB**

**RE: Those housing premises located in Calgary, Alberta and municipally described as:  
5420 Bannerman Drive NW  
Plan 3306JK Block 1 Lot 9**

**WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;**

**AND WHEREAS** such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. There is a tremendous mouse infestation in the house.
- b. There is a bad plumbing leak from the upstairs bathroom sink, rendering the sink unusable.
- c. There is no access to a shower or bathtub in the house.
- d. There is a severe combustion hazard in the house as all visible rooms were packed wall to wall, floor to ceiling with personal effects, electronics, rubbish, food items and various other clutter.

**AND WHEREAS** such inspection disclosed that the following breaches of the Public Health Act and the Nuisance and General Sanitation Regulation, Alberta Regulation 243/2003 exist in and about the above noted premises, namely:

- a. There is a tremendous mouse infestation in the house. This is in contravention of the Nuisance and General Sanitation Regulation, Alberta Regulation 243/2003, section 2.
- b. There is a bad plumbing leak from the upstairs bathroom sink, rendering the sink unusable. This is in contravention of the Nuisance and General Sanitation Regulation, Alberta Regulation 243/2003, section 2.
- c. There is no access to a shower or bathtub in the house. This is in contravention of the Nuisance and General Sanitation Regulation, Alberta Regulation 243/2003, section 2.
- d. There is a severe combustion hazard in the house as all visible rooms were packed wall to wall, floor to ceiling with personal effects, electronics, rubbish, food items and various other clutter. This is in contravention of the Nuisance and General Sanitation Regulation, Alberta Regulation 243/2003, section 2.

**AND WHEREAS**, by virtue of the foregoing, the above noted premises are hereby declared to be **Unfit for Human Habitation**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- a. That the occupants vacate the above noted premises immediately.
- b. That the owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
  - a. Remove all garbage, mouse droppings and excessive clutter from the house.
  - b. Thoroughly clean and sanitize the remaining belongings as well as all surfaces.
  - c. Rid the house of the mouse infestation.
  - d. Ensure all plumbing is in good working order and that there is unobstructed access to a fully functioning washroom facility.
- c. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain vacant and secure from unauthorized entry.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.

**YOU HAVE THE RIGHT TO APPEAL**

A person who a) is directly affected by a decision of a Regional Health Authority, and  
b) feels himself aggrieved by the decision

may appeal the decision within ten (10) days after receiving the order to the Public Health Appeal Board located at 24<sup>th</sup> Floor, Telus Plaza, 10025 - Jasper Avenue, Edmonton, Alberta, T5J 1S6. Telephone (780) 427-2813.

The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal. If you appeal, you may also make an application to the Board for a stay of this Order pending the appeal.
