

**ORDER OF AN EXECUTIVE OFFICER
UNFIT FOR HUMAN HABITATION
ORDER TO VACATE**

RE: Those housing premises located in Calgary, Alberta and municipally described as:

Unit 710 -108 3rd Avenue SW
Calgary Alberta
T2P 0E7

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above premises pursuant to the provisions of the **Public Health Act, RSA 2000, c. P-37, as amended;**

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. The entire kitchen floor, living room carpet and couches are soaked with human urine.
- b. The kitchen cupboards, counters and surfaces through out the unit are in a filthy condition.
- c. There are fruit flies throughout the unit, hundreds of flies have been crushed onto the wall surfaces in the unit.
- d. Used and dirty diapers stacked on top of the bathroom sink counter.
- e. As a result of the above conditions there is a strong and pungent odour in the unit that can be perceived in the hall.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

- a. The entire kitchen floor, living room carpet and couches are soaked with human urine. This is in contravention of the Nuisance and General Sanitation Regulation, specifically Section 2(1).
- b. The kitchen cupboards, counters and surfaces through out the unit are in a filthy condition This is in contravention of the Nuisance and General Sanitation Regulation, specifically Section 2(1).
- c. There are fruit flies throughout the unit, hundreds of flies have been crushed onto the wall surfaces in the unit. This is in contravention of the Nuisance and General Sanitation Regulation, specifically Section 2(1).
- d. Used and dirty diapers stacked on top of the bathroom sink counter. This is in contravention of the Nuisance and General Sanitation Regulation, specifically Section 2(1).
- e. As a result of the above conditions there is a strong and pungent odour in the unit that can be perceived in the hall way. This is in contravention of the Nuisance and General Sanitation Regulation, specifically Section 2(1).

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Unfit for Human Habitation**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- a. That the occupants vacate the above noted premises immediately.
- b. That the owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Ensure that all carpet and other flooring in the suite are removed and the entire subfloor that has been contaminated with urine is thoroughly cleaned and disinfected before installing a new floor.
 - b. The kitchen cupboards, counters and all surfaces throughout the unit must thoroughly cleaned and disinfected.
 - c. Rid the suite of fruit flies.
 - d. Properly dispose all used and dirty diapers.
 - e. Couches, clothes and other personal items that are made up of **absorbent** materials and that have been soaked with urine must be properly disposed to prevent any further contamination.
- c. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain vacant and secure from unauthorized entry.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.

YOU HAVE THE RIGHT TO APPEAL

A person who a) is directly affected by a decision of a Regional Health Authority, and
b) feels himself aggrieved by the decision

may appeal the decision within ten (10) days after receiving the order to the Public Health Appeal Board located at 24th Floor, Telus Plaza, 10025 - Jasper Avenue, Edmonton, Alberta, T5J 1S6. Telephone (780) 427-2813.

The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal. If you appeal, you may also make an application to the Board for a stay of this Order pending the appeal.
