

**IN THE MATTER OF THE PUBLIC HEALTH ACT – ALBERTA**  
**ORDER OF AN EXECUTIVE OFFICER**

**To: Shanda Lee Johnson**  
Unit 8, 6440 Centre Street NE  
Calgary, Alberta T2K 0V4  
(the “**Owner**”)

**Re:** The personal services facility located in Calgary, Alberta and municipally described as:  
  
Tattoo Girl  
Unit 8, 6440 Centre Street NE

WHEREAS I, an **Executive Officer** of the **Alberta Health Services**, have inspected the above noted Personal Services Facility pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted personal services facility which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. The owner did not obtain health approval prior to operating the personal services facility.
- b. Tattoos are being done in the kitchen of the home.
- c. There is no stainless steel hand sink installed in or readily accessible to the service provision area.
- d. There is no second stainless steel sink provided to be used for cleaning equipment.
- e. There is no evidence of an approved sterilizer onsite.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act, Personal Services Regulation, Alberta Regulation 20/2003, the Alberta Health Standards and Guidelines for Personal Services, October 1995, and the Alberta Health Standards and Guidelines for Tattooing, June 2002, exist in and about the above noted personal services facility, namely:

- a. The owner did not obtain health approval prior to operating the personal services facility. This is in contravention to Part I of Standards and Guidelines for Personal Services.
- b. Tattoos are being done in the kitchen of the home. This is in contravention of Section 5 of the Regulation.

- c. There is no stainless steel hand sink installed in or readily accessible to the service provision area. This is in contravention to Section 4(1) of the Regulation.
- d. There is no second stainless steel sink provided to be used for cleaning equipment. This is in contravention of Section 4(2) of the Regulation.
- e. There is no evidence of an approved sterilizer onsite. This is in contravention of Section 6(2) of the Regulation.

AND WHEREAS by virtue of the foregoing, the above noted premises are hereby declared to be **CLOSED**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately **CLOSE** the above noted personal services facility
2. That the Owner undertake and diligently pursue the completion of the following work in and about the above noted personal services facility, namely:
  - a. Obtain health approval prior to the operation of this personal services facility.
  - b. Develop a service provision area that is separate from any sleeping, dining, bathing, washroom or food preparation areas.
  - c. Install a stainless steel sink equipped with soap and paper towels that is used only by staff and clients for washing hands.
  - d. Install a second stainless steel sink to be used only by staff for cleaning equipment.
  - e. Obtain an approved autoclave to sterilize reusable equipment and instruments and maintain in accordance with the operation manual.
  - f. Until approval is granted, cease advertisement of the tattooing business to the public.
3. That, until such time as the work referred to in paragraph two is completed to the satisfaction of the undersigned, or an executive officer of the Calgary Health Region, the above noted premises shall remain **CLOSED**.
