

IN THE MATTER OF THE PUBLIC HEALTH ACT – ALBERTA
ORDER OF AN EXECUTIVE OFFICER

Re: The personal services facility located in Didsbury, Alberta and municipally described as:

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted Personal Services Facility pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted personal services facility which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. Tattooing has been performed in this residential home, an unsatisfactory location that is not separate from living, sleeping and dining areas, or other incompatible activities, including the presence of two dogs.
- b. There was no stainless steel sink set up for the sole purpose of washing hands or cleaning equipment and used only by the staff and clients of the personal service facility.
- c. There was no second stainless steel sink set up for the sole purpose of cleaning equipment and only used by the staff of the personal service facility.
- d. The tattooing service was not maintained in compliance with the Health Standards and Guidelines for Tattooing.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Personal Services Regulation, Alberta Regulation 20/2003 exist in and about the above noted personal services facility, namely:

- a. Tattooing has been performed in this residential home, an unsatisfactory location that is not separate from living, sleeping and dining areas, or other incompatible activities, including the presence of two dogs, contravening Section 5.

ORDER OF AN EXECUTIVE OFFICER

Re: The personal services facility Tattoos By Shawn located in Didsbury, Alberta and municipally described as 4 1210 23 Street:

- b. There was no stainless steel sink set up for the sole purpose of washing hands or cleaning equipment and used only by the staff and clients of the personal service facility contravening Section 4(1).
- c. There was no second stainless steel sink set up for the sole purpose of cleaning equipment and only used by the staff of the personal service facility contravening Section 4(2).
- d. The tattooing service was not maintained in compliance with the Health Standards and Guidelines for Tattooing, contravening Section 8.

AND WHEREAS by virtue of the foregoing, the above noted premises are hereby declared to be **closed**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the Owner immediately close the above noted personal services facility
- 2. That the Owner undertake and diligently pursue the completion of the following work in and about the above noted personal services facility, namely:
 - a. Refrain from all tattooing and related activities until such time as a premise and procedures to be followed by you for such personal services have been approved by Alberta Health Services.

That, until such time as the work referred to in paragraph two is completed to the satisfaction of the undersigned, or an executive officer of Alberta Health Services, the above noted premises shall remain closed.

Section 5(2) of the Public Health Act provides that a person who is directly affected by this Order and considers himself or herself aggrieved hereby may appeal the same to the Public Health Appeal Board, 24th Floor, Telus Plaza North Tower, 10025 Jasper Avenue, Edmonton AB T5J 2N3, within ten (10) days. The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal.
