WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted Personal Services Facility pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted personal services facility which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. No stainless steel hand wash/decontamination sink located in the skin invasive procedure area.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Personal Services Regulation, Alberta Regulation 20/2003 exist in and about the above noted personal services facility, namely:

- b. No stainless steel hand wash/decontamination sink located in the in skin invasive procedure area. This is in contravention of Section 4 of the Personal Services Regulation Section.

AND WHEREAS by virtue of the foregoing, the body and ear piercing services, of the above noted premises are hereby declared to be **closed**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately close the permanent makeup/tattoo services of the above noted personal services facility

ORDER OF AN EXECUTIVE OFFICER

Re: The personal services facility located in Strathmore, Alberta and municipally described as: Unit C, 134 2nd Street

2. That the Owner undertake and diligently pursue the completion of the following work in and about the above noted personal services facility, namely:
 - a. Install a stainless steel hand wash/decontamination sink in the permanent makeup/tattoo procedure area.
3. That, until such time as the work referred to in paragraph 2 is completed to the satisfaction of the undersigned, or an executive officer of Alberta Health Services, the above noted services shall remain closed.

The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal.

The Owner is advised that the Public Health Act empowers Alberta Health Services to carry out the terms of this Order on the Owner's behalf and at the Owner's expense should the Owner fail to comply with the terms hereof.
