WHEREAS I, an **Executive Officer** of the **Calgary Health Region**, have inspected the above noted swimming pool pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted swimming pool which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. The presence of total coliforms in the water sample collected on August 11, 2007.
- b. The presence of total coliforms in the water sample collected on August 10, 2007.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Swimming Pool, Wading Pool and Water Spray Park Regulation, Alberta Regulation 293/2006 exist in and about the above noted swimming pool, namely:

- a. The presence of total coliforms in the microbiological water sample collected on August 11, 2007 is in contravention of section 16 (c) of Swimming Pool, Wading Pool and Water Spray Park Regulation which states "the quality of water in a pool must be maintained so that samples of the water do not show the presence of coliforms in a 100 millilitre sample".
- b. The presence of total coliforms in the microbiological water sample collected on August 10, 2007 is in contravention of section 16 (c) of Swimming Pool, Wading Pool and Water Spray Park Regulation which states "the quality of water in a pool must be maintained so that samples of the water do not show the presence of coliforms in a 100 millilitre sample".

ORDER OF AN EXECUTIVE OFFICER

Re: Royal Wayne Motel Outdoor Pool located in Calgary, Alberta and municipally described as 2416 16 Ave. NW Calgary, Alberta

AND WHEREAS by virtue of the foregoing, the above noted premises are hereby declared to be **closed**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner **immediately close** the above noted swimming pool and secure it from unauthorized entry.
2. That the Owner undertake and diligently pursue the completion of the following work in and about the above noted swimming pool, namely:
 - a. Treat the pool water to eliminate the presence of total coliforms.
 - b. Take a water sample and submit it to the Provincial Laboratory for bacteriological analysis.
3. That until such time as the work referred to in paragraph 2 is completed to the satisfaction of the undersigned or an executive officer of the Calgary Health Region, **AND** a satisfactory microbiological result from the Provincial Laboratory is received as required in paragraph 2 (b) above, the above noted swimming pool shall remain closed and secured from unauthorized entry.

Section 5(2) of the Public Health Act provides that a person who is directly affected by this Order and considers himself or herself aggrieved hereby may appeal the same to the Public Health Appeal Board, 24th Floor, Telus Plaza North Tower, 10025 Jasper Avenue, Edmonton AB T5J 2N3, within ten (10) days. The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal.

The Owner is advised that the Public Health Act empowers the Calgary Health Region to carry out the terms of this Order on the Owner's behalf and at the Owner's expense should the Owner fail to comply with the terms hereof.
