WHEREAS I, an **Executive Officer** of the **Calgary Health Region**, have inspected the above noted swimming pool pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted swimming pool which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. Three consecutive unsatisfactory bacteriological water samples: the sample collected on July 28, 2008 had an heterotrophic plate count of 280 CFU per mL, the sample collected on August 5, 2008 had an heterotrophic plate count of 160 CFU per mL and the sample collected August 11, 2008 indicated the presence of total coliforms and had an heterotrophic plate count of 1100 CFU per mL.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Swimming Pool Regulation, Alberta Regulation 247/85 exist in and about the above noted swimming pool, namely:

Re: The Swimming Pool located in Banff, Alberta and municipally described as 453 Marten St., Banff, Alberta

- a. The last three consecutive bacteriological water samples were unsatisfactory as a result of high heterotrophic plate counts and the presence of total coliforms. This is in contravention of section 16 of the Swimming Pool Regulation, Alberta Regulation 247/85.

AND WHEREAS by virtue of the foregoing, the above noted premises are hereby declared to be **closed**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner **immediately close** the above noted swimming pool and secure it from unauthorized entry.
2. That the Owner undertake and diligently pursue the completion of the following work in and about the above noted swimming pool, namely:
 - a. Treat the pool water to eliminate any possible source of contamination and chemically balance the pool.
 - b. Submit two consecutive bacteriological water samples to the Provincial Laboratory for Public Health (Microbiology) for microbial testing.
3. That until such time as the work referred to in paragraph 2 is completed to the satisfaction of the undersigned, or an executive officer of the Calgary Health Region, **AND** the samples from 2(b) above have been received and confirmed as satisfactory the above noted swimming pool shall remain closed and secured from unauthorized entry.

The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal.
