

IN THE MATTER OF THE PUBLIC HEALTH ACT - ALBERTA
ORDER OF AN EXECUTIVE OFFICER

Re: The Centre Island Whirlpool located in Calgary, Alberta and municipally described as:
Deerfoot Inn & Casino Centre Island Whirlpool
Unit 1000
11500 35 Street SE
Calgary, Alberta

WHEREAS I, an **Executive Officer** of the **Alberta Health Services**, have inspected the above noted swimming pool pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted swimming pool which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. Three consecutive unsatisfactory bacteriological water sample results have been received. A sample collected on November 19, 2009 was not processed, a sample collected on November 26, 2009 had a Heterotrophic Plate Count of 2960 CFU per ml, and a sample collected on December 3, 2009 had Total Coliforms present.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Swimming Pool, Wading Pool and Water Spray Park Regulation, Alberta Regulation 293/2006 exist in and about the above noted swimming pool, namely:

- a. Three consecutive unsatisfactory bacteriological water sample results have been received. A sample collected on November 19, 2009 was not processed, a sample collected on November 26, 2009 had a Heterotrophic Plate Count of 2960 CFU per ml, and a sample collected on December 3, 2009 had Total Coliforms present. This is in contravention of Section 16 of the *Swimming Pool, Wading Pool and Water Spray Park Regulation (AR 293/2006)*.

AND WHEREAS by virtue of the foregoing, the above noted premises are hereby declared to be **closed**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner **immediately closes** the above noted whirlpool and secure it from unauthorized entry.
2. That the Owner undertake and diligently pursue the completion of the following work in and about the above noted whirlpool, namely:
 - a. Treat whirlpool water and equipment to eliminate any possible source of contamination then chemically balance the water.
 - b. Following treatment, submit a water sample to the Provincial Laboratory of Public Health.
3. That until such time as the work referred to in paragraph 2 is completed to the satisfaction of the undersigned, or an executive officer of the Alberta Health Services and the water sample submitted under paragraph 2(b) is deemed to be satisfactory, the above noted whirlpool shall remain closed and secured from unauthorized entry.

The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal.

The Owner is advised that the Public Health Act empowers Alberta Health Services to carry out the terms of this Order on the Owner's behalf and at the Owner's expense should the Owner fail to comply with the terms hereof.
