ORDER OF AN EXECUTIVE OFFICER

WHEREAS I, an **Executive Officer** of the **Calgary Health Region**, have inspected the above noted swimming pool and whirlpools pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted swimming pool and whirlpools which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. No water samples have been submitted to the Provincial Laboratory of Public Health for microbiological testing from the outdoor swimming pool, the whirlpool in the men's locker room or the whirlpool in the women's locker room for a period of four weeks.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Swimming Pool, Wading Pool and Water Spray Park Regulation, Alberta Regulation 293/2006 exist in and about the above noted swimming pool and whirlpools, namely:

- a. No water samples have been submitted to the Provincial Laboratory of Public Health for microbiological testing from the outdoor swimming pool, the whirlpool in the men's locker room or the whirlpool in the women's locker room for a period of four weeks which contravenes section 15(1) of the Swimming Pool, Wading Pool and Water Spray Park Regulation, Alberta Regulation 293/2006.

AND WHEREAS by virtue of the foregoing, the above noted premises are hereby declared to be **closed**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner **immediately close** the above noted swimming pool and whirlpools and secure them from unauthorized entry.
2. That the Owner undertake and diligently pursue the completion of the following work in and about the above noted swimming pool and whirlpools, namely:
 - a. Submit water samples from each of the outdoor swimming pool, the whirlpool in the men's locker room and the whirlpool in the women's locker room to the Provincial Laboratory of Public Health.
3. That until such time as the work referred to in paragraph 2 is completed to the satisfaction of the undersigned or an executive officer of the Calgary Health Region and the result of the laboratory tests on the water samples are satisfactory, the above noted swimming pool and whirlpools shall remain closed and secured from unauthorized entry.

Section 5(2) of the Public Health Act provides that a person who is directly affected by this Order and considers himself or herself aggrieved hereby may appeal the same to the Public Health Appeal Board, 24th Floor, Telus Plaza North Tower, 10025 Jasper Avenue, Edmonton AB T5J 2N3, within ten (10) days. The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal.

The Owner is advised that the Public Health Act empowers the Calgary Health Region to carry out the terms of this Order on the Owner's behalf and at the Owner's expense should the Owner fail to comply with the terms hereof.
