

**IN THE MATTER OF THE PUBLIC HEALTH ACT - ALBERTA**  
**ORDER OF AN EXECUTIVE OFFICER**

**Re:** The Whirlpool located in Calgary, Alberta and municipally described as:

WHEREAS I, an **Executive Officer** of the **Alberta Health Services**, have inspected the above noted whirlpool pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted whirlpool which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. Two consecutive unsatisfactory bacteriological water sample results have been received for the eastern whirlpool. Water samples taken on March 10, 2010 and March 17, 2010 had *Pseudomonas aeruginosa* isolated.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Swimming Pool, Wading Pool and Water Spray Park Regulation, Alberta Regulation 293/2006 exist in and about the above noted whirlpool, namely:

- a. Two consecutive unsatisfactory bacteriological water sample results have been received for the eastern whirlpool. Water samples taken on March 10, 2010 and March 17, 2010 had *Pseudomonas aeruginosa* isolated. This is in contravention of Section 16 of the Swimming Pool, Wading Pool and Water Spray Park Regulation (AR 293/2006).

AND WHEREAS by virtue of the foregoing, the above noted premises are hereby declared to be **closed**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

**ORDER OF AN EXECUTIVE OFFICER**

Re: **Acclaim Hotel Eastern Whirlpool located at 123 Freeport Blvd NE in Calgary, Alberta**

1. That the Owner **immediately close** the above noted whirlpool and secure it from unauthorized entry.
2. That the Owner undertake and diligently pursue the completion of the following work in and about the above noted whirlpool, namely:
  - a. Treat whirlpool water and equipment to eliminate any possible source of contamination then chemically balance the water.
  - b. Following treatment, submit a water sample to the Provincial Laboratory of Public Health.
3. That until such time as the work referred to in paragraph 2 is completed to the satisfaction of the undersigned, or an executive officer of the Alberta Health Services, and a satisfactory water sample has been received, the above noted whirlpool shall remain closed and secured from unauthorized entry.

Dated at Calgary, Alberta, this 22<sup>nd</sup> day of March, 2010, following a verbal order issued on the 19<sup>th</sup> of March, 2010.
