

IN THE MATTER OF THE PUBLIC HEALTH ACT - ALBERTA  
ORDER OF AN EXECUTIVE OFFICER

**To: Rideau Ridge Townhomes

**Re:** The Swimming Pool located in Calgary, Alberta and municipally described as:  
  
Rideau Ridge Townhomes  
3201 Rideau Place SW  
Calgary, Alberta

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted swimming pool pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted swimming pool which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. Two consecutive unsatisfactory bacteriological water sample results have been received. Water samples taken on July 15, 2010 and July 24, 2010 had *Total Coliforms* present.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Swimming Pool, Wading Pool and Water Spray Park Regulation, Alberta Regulation 293/2006 exist in and about the above noted swimming pool, namely:

- a. Two consecutive unsatisfactory bacteriological water sample results have been received. Water samples taken on July 15, 2010 and July 24, 2010 had *Total Coliforms* present. This is in contravention of Section 16 of the Swimming Pool, Wading Pool and Water Spray Park Regulation (AR 293/2006).

AND WHEREAS by virtue of the foregoing, the above noted premises are hereby declared to be **closed**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner **immediately closes** the above noted swimming pool and secure it from unauthorized entry.

2. That the Owner undertake and diligently pursue the completion of the following work in and about the above noted swimming pool, namely:
  - a. Treat swimming pool water and equipment to eliminate any possible source of contamination then chemically balance the water.
  - b. Following treatment, submit a water sample to the Provincial Laboratory of Public Health.
3. That until such time as the work referred to in paragraph 2 is completed to the satisfaction of the undersigned, or an executive officer of Alberta Health Services, the above noted swimming pool shall remain closed and secured from unauthorized entry.

The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal.***

***The Owner is advised that the Public Health Act empowers Alberta Health Services to carry out the terms of this Order on the Owner's behalf and at the Owner's expense should the Owner fail to comply with the terms hereof.***
