

## ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE

**RE:** The swimming pool located in Airdrie, Alberta and municipally described as:

Comfort Inn & Suites  
133 Sierra Springs Drive  
Airdrie, Alberta  
T4B 3G7

**WHEREAS** I, an **Executive Officer** of **Alberta Health Services**, have inspected the above premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

**AND WHEREAS** such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. The bacteriological water sample taken on July 12<sup>th</sup>, 2011, indicated bacterial contamination consisting of a HPC count of 220 CFU per mL.
- b. The bacteriological water sample taken on July 19<sup>th</sup>, 2011, indicated bacterial contamination consisting of a HPC count of 290 CFU per mL.
- c. The bacteriological water sample taken on July 26<sup>th</sup>, 2011, indicated bacterial contamination consisting of a HPC count of 180 CFU per mL.

**AND WHEREAS** such inspection disclosed that the following breaches of the Public Health Act and the Swimming Pool, Wading Pool and Water Spray Park Regulation, Alberta Regulation 293/2006 exist in and about the above noted swimming pool, namely:

- a. The bacteriological water sample submitted on July 12<sup>th</sup>, 2011, indicated bacterial contamination consisting of a HPC count of 220 CFU per mL. This is in contravention to Section 16 (a) of the Swimming Pool Regulation.

- b. The bacteriological water sample submitted on July 19<sup>th</sup>, 2011, indicated bacterial contamination consisting of a HPC count of 290 CFU per mL. This is in contravention to Section 16 (a) of the Swimming Pool Regulation.
- c. The bacteriological water sample taken on July 26<sup>th</sup>, 2011, indicated bacterial contamination consisting of a HPC count of 180 CFU per mL. This is in contravention to Section 16 (a) of the Swimming Pool Regulation.

**AND WHEREAS**, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately close the above noted swimming pool.
2. That the owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
  - a. Treat the swimming pool water to eliminate any possible source of contamination.
  - b. Submit a bacteriological water sample to the Provincial Laboratory.
3. That until such time as the work referred to in paragraph 2a is completed to the satisfaction of the undersigned, or an executive officer of Alberta Health Services, and the sample from 2b has been confirmed satisfactory, the above noted swimming pool shall remain closed and secured from unauthorized entry.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.

The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal. If you appeal, you may also make an application to the Board for a stay of this Order pending the appeal.
