WHEREAS I, an **Executive Officer** of the **Calgary Health Region**, have inspected the above noted Social Care Facility pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted social care facility which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. A break in the municipal water main has resulted in no water supply to the daycare.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act, the Institutions Regulation, Alberta Regulation 143/1981, and the Food Regulation, Alberta Regulation 31/2006 exist in and about the above noted social care facility, namely:

- a. A break in the municipal water main has resulted in no water supply to the daycare. This is a breach of section 18 of the Institutions Regulation, Alberta Regulation 143/1981 and 17(1)(f)(i) of the Food Regulation, Alberta Regulation 31/2006.

ORDER OF AN EXECUTIVE OFFICER

Re: The Food Establishment located in Calgary, Alberta and municipally described as 10620 Sacramento Drive, Calgary, Alberta

AND WHEREAS by virtue of the foregoing, the above noted premises is hereby declared to be **closed**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately **close** the above noted social care facility.
2. That the Owner undertake and diligently pursue the completion of the following work in and about the above noted social care facility, namely:
 - a. Ensure municipal water supply is re-established.
3. That, until such time as the work referred to in paragraph 2 is completed to the satisfaction of the undersigned, or an executive officer of the Calgary Health Region, the above noted shall remain closed.

The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal.

The Owner is advised that the Public Health Act empowers the Calgary Health Region to carry out the terms of this Order on the Owner's behalf and at the Owner's expense should the Owner fail to comply with the terms hereof.
